Are there any tax implications if I leave a gift to SURVIVE-MIVA in my Will?

Yes—in a positive way. Currently, UK registered charities are exempt from Inheritance Tax so money left to SURVIVE-MIVA in your Will is deducted from your Estate before Inheritance Tax is calculated—this may mean that your family/inheritors have less tax to pay.

Is it possible to leave my house to SURVIVE-MIVA?

This is a generous offer, but SURVIVE-MIVA isn't equipped to deal with properties. We would prefer that all assets of your Estate were sold by the executors of your Will and SURVIVE-MIVA's share sent on to us as a cheque or via a bank transfer.

Do I have to use a solicitor to draw up my Will?

No, but we recommend that you do. A solicitor will make sure that the wording of your Will is precise and clear so that your money and goods will definitely get to the people and organisations you wish to benefit.

I have already drawn up my Will. Is it easy to alter my Will to leave some money to SURVIVE-MIVA ?

Yes, you just need to complete a simple codicil form (available from SURVIVE-MIVA) and send it to your solicitor.

Does SURVIVE-MIVA need to know that I have left them a gift in my Will?

No, but knowing you intend to do so gives us confidence to plan for the future.
